### General Regulations

#### 1) INTRODUCTION

With the aim of promoting Italian and international jazz ensembles CremonaFiere organizes CREMONA MONDOMUSICA JAZZ CLUB.

It is a **properly equipped area** within "Cremona Mondomusica 2010 – The International exhibition of handcrafted musical instruments and violin making accessories" (Cremona Fairgrounds) **created to allow the performance of national and international jazz ensembles.**

#### 2) PARTICIPANTS

Admission is free.

Are admitted to perform (Annex 1) Italian and foreign jazz bands coming from private and public Conservatories and Music Schools presenting a free repertoire from different jazz genres: from *Dixieland to swing, from post-bop to free*. Fusions with other music genres such as *classical, latin, manouche, rock, funky* and *electronic music* are welcome. Ensembles with under-age musicians are also admitted upon delivery of a liability release declaration signed by parents/guardian (**Annex 2**).

There is no limit of age and it is not required a specific equipment even if the organization will give priority to musicians under the age of 30 and ensembles with at least one stringed instrument (in addition to the double bass). The standard ensemble will range from three to seven members. Piano soloists, duets and big bands of a maximum of 15 musicians can be also admitted after specific technical evaluation.

#### 3) APPLICATION FORMS

**The closing date for the receipt of all entries is ~~July 10,~~ September 1, 2010.**

#### 4) INSTRUCTIONS FOR STAGE USE AND PERFORMANCES

a) Stage performances will take place

**from 11:00 a.m. to 6:00 p.m. without interruption from October 1 to 3, 2010.**

b) Every ensemble will have **30 minutes** of stage *performance*.

The Organization reserves the right to allow a shorter or longer performance upon participants' request.

c) The confirmation of acceptance and the communication of the specific day and time of the musical performance will be sent by the organization **from September 1, 2010 to the fax or e-mail indicated in the application form.**

d) On the website [www.cremonamondomusica.it](http://www.cremonamondomusica.it) will be available the updated list of participants, with dates and times. CremonaFiere reserves the right to communicate some slightest changes even on the day of the performance.

e) Overruns of the allocated time will not be allowed. If the band starts performing late, there will be less time available.

f) Bands must be reliable and punctual. Participants who will not be able to be present on the day communicated by the organization or, for any reason, unable to perform in the day and time established by the

organization will be automatically cancelled. Cancellation gives the organizer the right to substitute the performer with another group or artist.

If the impossibility to participate is notified in writing (e-mail or fax) to CremonaFiere Spa **within September 16, 2010**, it will be possible to consider a change in the timetable compatible with the reservations of other groups' performances.

**g)** To reduce intermissions between performances the stage will be equipped with a drum set (bass drum, snare drum, 2 toms, 1 floor tom, charleston, 1 ride, 1 crash) a piano and a double bass. It will be also possible to put a microphone on other instruments (except for brass instruments and single-reed instruments) and vocalist/s. Every band should bring its own instruments (except the double bass, the drum set and the piano).

## **5) COPYRIGHT**

---

By signing the application form the encharged representative of the ensemble (or the soloist, in case of a solo performance) grants to CremonaFiere, on behalf of all

members, the right to:

**a)** play, record, disclose and distribute by any means the performance of the band beyond territorial limits and passages .

**b)** to publish and reproduce without limits the images of the performances and the backstage on leaflets, magazines,albums, collections, products etc., and also during commercial and advertising activities.

The encharged representative of the band (or the soloist) in the name and on behalf of its members declares and ensures:

**c)** to have obtained all the necessary consents of every possible holder of property rights, including copyright and related rights, image rights and all licenses and releases regarding performed pieces of music.

**d)** To renounce to any copyright royalties or related rights and to waive any claims against Cremonafiere spa. I also waive any right deriving from photographic and phonografic reproduction and radio and television broadcasting of the performance.

**e)** to waive any claims against Cremonafiere for failure or delay in performance due to any reason.

## **6) CHARGES**

---

No charge will be laid against CremonaFiere. All travel expenses, room and board related to the performance at Cremona Mondomusica Jazz Club will be paid by the band.

## **7) CHANGES TO GENERAL REGULATIONS**

---

Any change to the current General Regulations, also related to established times and dates, will be published on the exhibition website and made at the organizer own discretion.

## **8) PRIVACY NOTE**

---

Data are collected in compliance with Legislative Decree no. 196/2003. This information will be processed manually and/or electronically for statistical and marketing purposes, and for updates regarding CremonaFiere events by means of the sending of informative material, including from third parties. In addition, such data will be used for the publishing of the Official Exhibition Catalogue and published on the CremonaFiere website.
